- Insurer:** The Insurer is LB Forsikring A/S, business reg. no. 16500836, FT no. 53040, Amerika Plads 15, DK-2100 Copenhagen Ø (LB Forsikring).
- Policyholder:** The policyholder is Jordemoderforeningen, business reg. no. 30833813 Sankt Annæ Plads, DK-1250 Copenhagen K.
- Insured:** The insurance covers you and other midwifery students who are members of Jordemoderforeningen.
- Cover:** The insurance may cover for compensation that may be made against you for injury to other parties or damage to the property of other parties occurring while you are exercising your work during the internship period that forms part of your education as a midwife.
- The insurance covers internships in Denmark. In addition, internships outside Denmark are covered for up to 90 days.
- The cover is secondary and only applies in cases where the liability is neither covered by the insurance policies of the educational institution or the internship organisation nor by other private or commercial insurance policies.
- The complete terms and conditions governing payout under the insurance can be found in subsection 52-2 of the policy wording.
- Sum insured:** **DKK 10 million** for personal injury
DKK 5 million for property damage
- The sum insured is not index-linked.
- The sum insured is the maximum total amount that may be paid out during a policy year for all claims reported to the Insurer by all the parties covered by the insurance.
- Payment:** Jordemoderforeningen pays the insurance premium.

- Effective date:** You are covered by the insurance with effect from 00.00 hours on the first day after you have become registered as a member of Jordemoderforeningen in your capacity as midwifery student. 2/2
- Termination:** The insurance terminates if the joint agreement between LB Forsikring and Jordemoderforeningen is terminated, or when your membership of Jordemoderforeningen is terminated. If your membership of Jordemoderforeningen is terminated, the cover under the policy will terminate at the end of the last calendar month for which you have paid your membership fees.
- Claim notification:** You must immediately notify LB Forsikring if a claim for compensation is made against you. You can contact LB Forsikring on +45 33 11 77 55. If you report a claim for compensation to LB Forsikring, you must grant your consent to LB Forsikring contacting Jordemoderforeningen for confirmation of your membership.
- Complaints:** If you disagree with a decision made by LB Forsikring, you may submit a complaint to LB Forsikring. If you fail to achieve the desired outcome, you may submit a complaint to the Danish Insurance Complaints Board.
